


INTRODUCTION ABOUT FRESH OR DRIED DATES

Dates are one of the oldest tree crops from the Middle East, dating back to more than 5000 years ago. The fruit was commonly traded and date palm tree orchards grew throughout the Middle East. Later trading spread the palm trees to Northeast Africa and Eastern Mediterranean regions.

The benefits of dates include relief from constipation, intestinal disorders, heart problems, anemia, diarrhea, abdominal cancer, and many other conditions. Dates also help for a healthy weight gain. They are rich in several vitamins, minerals, and fiber. These delicious fruits contain oil, calcium, sulfur, iron, potassium, phosphorous, manganese, copper and magnesium, which are all beneficial for health.

Egypt is the world leader in date production and cultivation. Each year, this country produces approximately 1,084,529 metric tons of dates. This represents a little over 17% of global date production but only 3% of world exports.

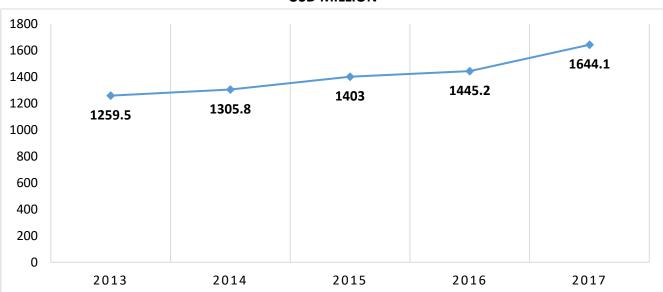

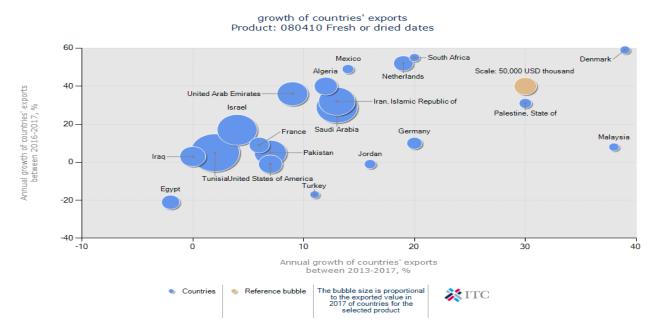

ALSO, EGYPT IS ONE OF THE BIGGEST DATE PRODUCERS IT WAS RANKED TO BE THE 12TH LARGEST WORLDWIDE EXPORTING COUNTRY THAT SHARED WITH ALMOST 2.0% FROM WORLD EXPORTS IN 2017.

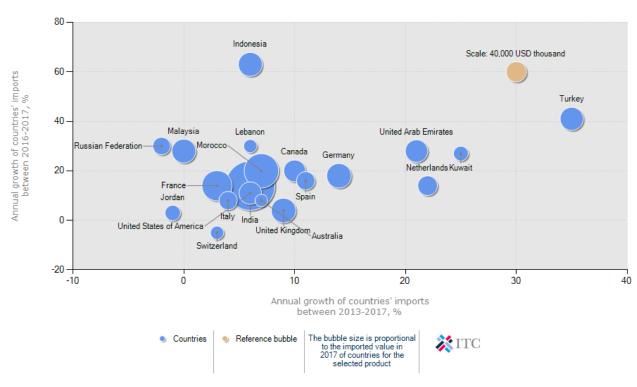

GROWTH OF COUNTRIES IMPORTS FOR FRESH OR DRIED DATES CATEGORY (HS CODE: 080410)





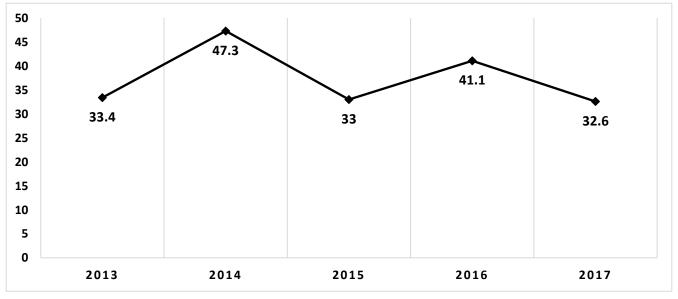


EGYPTIAN IMPORTS OF FRESH OR DRIED DATES CATEGORY (HS CODE: 080410)

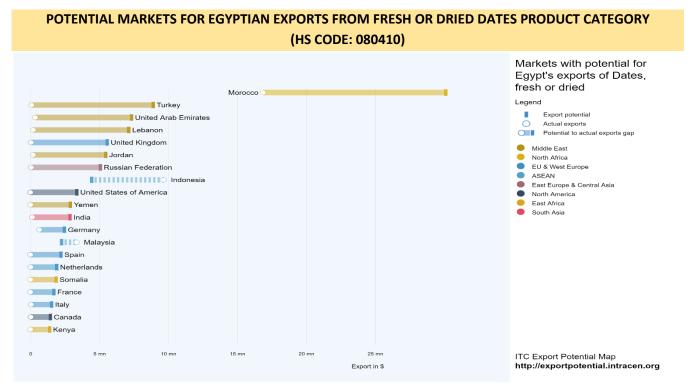

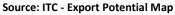
METHODOLOGY:

EXPORT POTENTIAL MAP:

Export Potential map is a strategic tool used by International Trade Centre (ITC) to identify market opportunities and investment resources where they will have the greatest return in the long run. Market potential analysis is not used for short-term forecasting, but can help to target markets with high growth potential in the future. Market potential analysis enables governaments and companies to:

- Categorize countries as lead markets, break-out markets or emerging markets.
- Quantify market potential for a given product by country, region or globally, now and in the future.
- Identify growth drivers and barriers in those markets.
- Understand how to exploit growth markets by tailoring marketing, product development and production strategies to meet customer demands and overcome market barriers.





The markets with greatest potential for Egyptian exports of (HS Code: 080410) FRESH OR DRIED DATES are **Morocco, Turkey** and **United Arab Emirates** followed by **Lebanon, United Kingdom** and **Jordan**. Morocco shows the largest absolute difference between potential and actual exports in value terms, leaving room to realize additional exports worth \$16.9 million. <u>The next section will focus on profiling</u> **the target market (s) in details.**

POLITICAL OVERVIEW:

The United Kingdom (UK) consists of England, Wales, Scotland (who together make up Great Britain) and Northern Ireland. The UK's geography is varied, and includes cliffs along some coastlines, highlands and lowlands and many islands off the coast of Scotland.

The United Kingdom is a constitutional monarchy and parliamentary democracy. The main chamber of parliament is the lower house, the House of Commons, which has 646 members elected by universal suffrage. About 700 people are eligible to sit in the upper house, the House of Lords, including life peers, hereditary peers, and bishops. There is a Scottish parliament in Edinburgh with wide-ranging local powers, and a Welsh Assembly in Cardiff which has more limited authority for Welsh affairs but can legislate in some areas. **Source: World Bank**

ECONOMIC OVERVIEW:

The UK, a leading trading power and financial center, is the third largest economy in Europe after Germany and France. Agriculture is intensive, highly mechanized, and efficient by European standards, producing about 60% of food needs with less than 2% of the labor force. The UK has large coal, natural gas, and oil resources, but its oil and natural gas reserves are declining; the UK has been a net importer of energy since 2005. Services, particularly







banking, insurance, and business services, are key drivers of British GDP growth. Manufacturing, meanwhile, has declined in importance but still accounts for about 10% of economic output.

In 2008, the global financial crisis hit the economy particularly hard, due to the importance of its financial sector. Falling home prices, high consumer debt, and the global economic slowdown compounded the UK's economic problems, pushing the economy into recession in the latter half of 2008 and prompting the then BROWN (Labor) government to implement a number of measures to stimulate the economy and stabilize the financial markets. Facing burgeoning public deficits and debt levels, in 2010 the then CAMERON-led coalition government (between Conservatives and Liberal Democrats) initiated an austerity program, which has continued under the Conservative government. However, the deficit still remains one of the highest in the G7, standing at 3.6% of GDP as of 2017, and the UK has pledged to lower its corporation tax from 20% to 17% by 2020. The UK had a debt burden of 90.4% GDP at the end of 2017.

The UK's economy has begun to slow since the referendum vote to leave the EU in June 2016. A sustained depreciation of the British pound has increased consumer and producer prices, weighing on consumer spending without spurring a meaningful increase in exports. The UK has an extensive trade relationship with other EU members through its single market membership and economic observers have warned the exit will jeopardize its position as the central location for European financial services. Prime Minister MAY is seeking a new "deep and special" trade relationship with the EU following the UK's exit. However, economists doubt that the UK will be able to preserve the benefits of EU membership without the obligations

IMPORT REQUIREMENTS AND DOCUMENTATION:

An import license is not needed to import the majority of industrial goods into the UK or EU. However, some industrial goods require import licenses issued by the Import Licensing Branch (ILB) as a result of controls imposed at national, EU or UN level. ILB publicizes these restrictions by issuing Notices to Importers. The Department for International Trade's (DIT) Import Licensing Branch is the UK licensing authority. A list of EU licensing authorities is available by contacting the DIT Import Licensing Branch import controls. The Department of International Trade provide further guidance on import controls.

There are numerous goods which are currently subject to import controls, whether because they are banned, subject to quotas or where the import is monitored with licenses. Examples of goods currently banned include offensive weapons (i.e. switch blades), self-defense sprays (i.e. pepper spray) and rough diamonds. The import of firearms is subject to monitoring.

There are certain goods that cannot be brought into the UK under any circumstances, and some goods that are restricted. This is to protect the UK from crime, pests and diseases. The following goods are banned completely regardless of country of origin: illicit drugs, flick and gravity knives, self-defense sprays such as pepper and CS gas sprays, stun guns, indecent and obscene material and counterfeit, pirated and patent-infringing goods. The UK government provides current and complete information on banned or restricted goods.

Customs duty is assessed on the fair market value of imported goods at the time they are landed in the UK. Import prices for products entering the UK from non-EU states generally consist of: Cost, Insurance, Freight and Duty, with VAT of 20% levied on the aggregate value.

The commercial invoice value is usually accepted as the normal price, but if a preferential arrangement has been established between the overseas supplier and the importer, or an unrealistic value has been declared, HM Revenue and Customs (HMRC) reserves the right to assess a fair market value for duty purposes. The duty is payable at the time the goods are imported, but established importers can defer payment for, on average, 30 days. In addition to customs duties on imported goods, an excise tax is levied on in-country sales of alcohol, tobacco, and road vehicles, and on sales of oil and petroleum products.









United Kingdom's imports from Egypt for this product showed a growth rate in value of 183 % last year and declination in quantity with a rate of 16% between 2013 and 2017.

The unit value of the product Exported from Egypt to Morocco is 2957 US Dollars / ton which gives Egypt a comparative advantage, as it is less than five of United Kingdom's top 10 suppliers.
