


INTRODUCTION ABOUT FRESH OR DRIED DATES

Dates are one of the oldest tree crops from the Middle East, dating back to more than 5000 years ago. The fruit was commonly traded and date palm tree orchards grew throughout the Middle East. Later trading spread the palm trees to Northeast Africa and Eastern Mediterranean regions.

The benefits of dates include relief from constipation, intestinal disorders, heart problems, anemia, diarrhea, abdominal cancer, and many other conditions. Dates also help for a healthy weight gain. They are rich in several vitamins, minerals, and fiber. These delicious fruits contain oil, calcium, sulfur, iron, potassium, phosphorous, manganese, copper and magnesium, which are all beneficial for health.


Egypt is the world leader in date production and cultivation. Each year, this country produces approximately 1,084,529 metric tons of dates. This represents a little over 17% of global date production but only 3% of world exports.


World exports was amounted be to USD 1644.1 Million in 2017 with a positive change of 13.8 % compared to exports value in 2016. Iran was the biggest exporter shared with 15.2% from world exports.

ALSO, EGYPT IS ONE OF THE BIGGEST DATE PRODUCERS IT WAS RANKED TO BE THE 12TH LARGEST WORLDWIDE EXPORTING COUNTRY THAT SHARED WITH ALMOST 2.0% FROM WORLD EXPORTS IN 2017.



GROWTH OF COUNTRIES IMPORTS FOR FRESH OR DRIED DATES CATEGORY (HS CODE: 080410)




growth of countries' imports Product: 080410 Fresh or dried dates




EGYPTIAN IMPORTS OF FRESH OR DRIED DATES CATEGORY (HS CODE: 080410)




METHODOLOGY:

EXPORT POTENTIAL MAP:

Export Potential map is a strategic tool used by International Trade Centre (ITC) to identify market opportunities and investment resources where they will have the greatest return in the long run. Market potential analysis is not used for short-term forecasting, but can help to target markets with high growth potential in the future. Market potential analysis enables governaments and companies to:

- Categorize countries as lead markets, break-out markets or emerging markets.
- Quantify market potential for a given product by country, region or globally, now and in the future.
- Identify growth drivers and barriers in those markets.
- Understand how to exploit growth markets by tailoring marketing, product development and production strategies to meet customer demands and overcome market barriers.





The markets with greatest potential for Egyptian exports of (HS Code: 080410) FRESH OR DRIED DATES are **Morocco, Turkey** and **United Arab Emirates** followed by **Lebanon, United Kingdom** and **Jordan**. Morocco shows the largest absolute difference between potential and actual exports in value terms, leaving room to realize additional exports worth \$16.9 million. <u>The next section will focus on profiling</u> **the target market (s) in details.**

POLITICAL OVERVIEW:

The executive power is shared between the government and the King. The Prime Minister is promoted to head of government and as such presides over the Governing Council but the Council of Ministers continues to be chaired by the King. The Government Council consists of all the ministers, deputy ministers and other Secretaries of State. It discusses public and sectoral policies, the commitment of the government's responsibility to the House of Representatives, current issues related to human rights and public order, bills, decrees, draft regulatory decrees and the appointment of secretaries and central directors of the public administration, university presidents, deans and directors of schools and higher institutes. The Governing Council only has deliberative power in terms of general policy of the State, international conventions, the finance bill. The Council of Ministers, where only the head of government and the ministers sit, is responsible for the strategic direction of the state policy, the revision of the Constitution, draft organic laws, general guidance of the finance bill, amnesty, draft texts related to the military, the declaration of a state of siege, the declaration of war

ECONOMIC OVERVIEW:

Morocco has capitalized on its proximity to Europe and relatively low labor costs to work towards building a diverse, open, market-oriented economy. Key sectors of the economy include agriculture, tourism, aerospace, automotive, phosphates, textiles, apparel, and subcomponents. Morocco has increased investment in its port, transportation, and industrial infrastructure to position itself as a center and broker for business throughout Africa. Industrial development strategies and infrastructure improvements - most visibly illustrated by a new port and free trade zone near Tangier - are improving Morocco's competitiveness.

In the 1980s, Morocco was a heavily indebted country before pursuing austerity measures and pro-market reforms, overseen by the IMF. Since taking the throne in 1999, King MOHAMMED VI has presided over a stable economy marked by steady growth, low inflation, and gradually falling unemployment, although poor harvests and economic difficulties in Europe contributed to an economic slowdown. To boost exports, Morocco entered into a bilateral Free Trade Agreement with the US in 2006 and an Advanced Status agreement with the EU in 2008. In late 2014, Morocco eliminated subsidies for gasoline, diesel, and fuel oil, dramatically reducing outlays that weighed on the country's budget and current account. Subsidies on butane gas and certain food products remain in place. Morocco also seeks to expand its renewable energy capacity with a goal of making renewable more than 50% of installed electricity generation capacity by 2030.

Despite Morocco's economic progress, the country suffers from high unemployment, poverty, and illiteracy, particularly in rural areas. Key economic challenges for Morocco include reforming the education system and the judiciary


IMPORT REQUIREMENTS AND DOCUMENTATION:

The following documentation is required for all imports and exports:

- A license representing the "physical import or export."
- A commercial invoice: Pro-forma invoices are provided in most cases. No special invoice form is necessary. The commercial or pro-forma invoice should:
 - Be on the supplier's letterhead,
 - Fully describe the goods in French,
 - Indicate the HS code when available,
 - Indicate the value of the goods,
 - Indicate the currency for payment (for foreign exchange transfer),
 - Indicate the address of the buyer, and
- An "import commitment" (engagement importation), which is the authorization provided by the exchange office for transfer of foreign currencies from Morocco to foreign suppliers abroad.
- A "customs declaration" (declaration de Duane) is provided by the customs office and is required for import and export through a port or airport. For shipments by mail, a simple form filled out at the post office replaces the "declaration de Duane."
- The importer/exporter may attach any documentation, such as technical documentation, that might help the customs office. The authority for Customs in Morocco is the <u>Administration of Customs</u> and <u>Indirect Tax</u>


MOROCCO IN DOING BUSINESS REPORT 2018:










Egypt is the 3rd supplier of the subject product (HS Code: 080410) to Morocco with a value of USD 12 million and a quantity of 12249 tons. Morocco's imports from Egypt for this product showed a declination rate in value of 38 % last year and growth in quantity with a rate of 10% between 2013 and 2017.

The unit value of the product Exported from Egypt to Morocco is 983 US Dollars / ton which gives Egypt a comparative advantage, as it is the Second least unit value among Morocco's top 10 suppliers.
